

IED Dynamics for EMS/Medical Professionals

December 8, 2016



Course Description:

IED Dynamics for EMS/Medical Professionals is designed to provide a comprehensive overview of Improvised Explosive Devices (IED) and the medical response to an IED attack, including the types of blast injuries, specifically considering events such as the 2013 Boston Marathon Bombing. This course is primarily focused towards emergency medical services (EMS) and medical professionals to assist in the execution of their duties. The course will cover a brief history of the use of IEDs and their evolution as a terrorist attack weapon.

This course will also familiarize EMS and medical professionals with the various types, components, and attack methods of IEDs. The course includes discussion based scenarios that will guide emergency personnel through the attack cycle in relation to the IED manufacturing process while identifying points of observable activity that can be communicated to emergency responders. Students will also be exposed to a Home-Made Explosive (HME) laboratory in order to facilitate discussion on IED dynamics pertaining to the attack cycle.

This course is being taught by a team of instructors from the State Preparedness Training Center and the National Center for Security & Preparedness.
