**The Academy will be managed by an Incident Management Team utilizing the Incident Command System, follow the ICS planning process with preparation of a daily Incident Action Plan (IAP). Operational Briefings will be provided daily at the Academy. Students will be able to meet and observe an Incident Management Team in operation under the Incident Command System.**

**Lodging:** You are eligible for lodging if your residence and official work station are more than 50 miles from the training center and you are a state or local agency first responder from New York. Lodging is not available for federal employees or private industry participants.

You must request lodging at the time of training registration. If approved for lodging, you will receive an email with further instructions. Students should not reserve a room without receiving proper approval from SPTC first. Once you receive the letter of approval, you must contact your hotel of choice directly by telephone from the List of Approved Hotels and reserve your own room as a DHSES-SPTC registered student. The List of Approved Hotels can be found at <https://www.dhSES.ny.gov/lodging>. Any person who reserves a room without the proper approval may be held personally responsible for and charges incurred. Any person who reserves a room and stays overnight prior to being registered for training at the SPTC, and plans to register on the day of training, will be held personally responsible for all charges related to their stay if the class is already full.

Use of a hotel website or third-party booking service (such as Orbitz or Priceline) may result in a higher rate which you will be responsible for. A credit card will hold your room and must be provided at check-in to cover incidentals during your stay. Students requesting accommodations must attend all required course sessions to be eligible for funding. Failure to attend all sessions will result in the applicant being responsible for all expenses incurred.

### Courses Offered:

#### **Newly Added:**

##### **ICS-300 Intermediate ICS For Expanding Incidents - September 26 - 28, 2022**

This course is designed to enable senior staff personnel to operate efficiently during an incident or event within the Incident Command System (ICS). This course focuses on management of expanding incidents and was developed under the leadership of the NWCG and complies with the NIMS/HSPD-5 requirements for Incident Command System training. ##### **G-191 ICS/EOC Interface - September 26, 2022**

This course will analyze given scenarios to determine commonalities and potential interface issues between ICS and EOCs. It will contrast the typical role and functions of the Incident Command and the EOC during emergency operations. [Register Here](#)

##### **G-289 Public Information Officer (PIO) Awareness -September 26, 2022**

This course will orient the participants to the public information function and the role of the PIO in the public safety/emergency management environment. [Register Here](#)

##### **Traffic Incident Management System (TIMS) - September 26, 2022**

The course covers the process of coordinating resources of several different partner agencies and private sector companies to detect, respond to, and clear traffic incidents as quickly as possible to reduce the impacts of incidents on safety and congestion. Protecting the safety of responders and motorists, how to make a quick response, and effective communications at traffic incident scenes are highlighted. [Register Here](#)

##### **L-965 Resources Unit and Demobilization Unit Leader (RESL) - September 26 -29, 2022**

The course provides an overview of Unit Leader responsibilities, the Planning Section and the planning process to contextualize the Resource Unit for students unfamiliar with the planning process or the Incident Command System (ICS). It explores RESL functions and responsibilities including resource tracking systems, operational planning, and resource products/outputs. The Status/Check-in and Demobilization functions are covered to provide students with the knowledge to perform those duties if necessary. [Register Here](#)

### **L-987 Introduction to Air Operations -September 26 - 27, 2022**

This course is intended to familiarize students with the basic concepts of air operations as associated with deployment through Incident Management Teams (IMTs). Students should hold current FAA Part 61 and/or Part 107 certificates and be familiar with the potential interface between manned and unmanned aircraft operations during an incident. ### **L-986 Air Support Group Supervisor - September 28 - 30, 2022**

The course is intended to provide local and State level emergency responders with an overview of key duties and responsibilities of an ASGS on a Type 3 All-Hazards Incident Management Team (AHIMT). Students should hold current FAA Part 61 and/or Part 107 certificates and be familiar with the potential interface between manned and unmanned aircraft operations during an incident. ### **L-950 Incident Commander - September 26 - 30, 2022**

This course is designed to provide local and state-level emergency responders with a robust understanding of the duties, responsibilities, and capabilities of an effective IC on an All-Hazards Incident Management Team. [Register Here](#)

### **G-2200 Basic EOC - September 27, 2022**

The Basic Emergency Operations Center Functions course is designed to introduce the role, design, and function of the Emergency Operations Center (EOC) and the supportive relationship as a NIMS Command and Coordination component of the Multiagency Coordination System. [Register Here](#)

### **G-290 Basic Public Information - September 27, 2022 - 28, 2022**

This course uses Bloom's Taxonomy as a guide to focus the course material to augment the knowledge and comprehension for new PIOs. This course will consider the value of communication before, during and after an incident. It will help PIOs identify critical audiences, both internal and external. [Register Here](#)

### **IS-2300 Intermediate EOC Functions - September 28 - 30, 2022**
