



Training Announcement: Integrated Response to Aggressive Deadly Behavior

June 2-4, 2026

State Preparedness Training Center

Course Description

Integrated Response to Aggressive Deadly Behavior (IRADB) is designed to prepare law enforcement (LE) and emergency medical services (EMS) to mount an effective integrated response to an incident involving aggressive deadly behavior (ADB).

An increasing number of communities across the county are relying on rescue task forces or other methods of integrated response during critical incidents. The need for effective, unified command and decision-making among EMS, LE and other response agencies is vital. Through interactive discussions, skill lanes, and scenario-based activities, students will enhance their ability to mitigate loss of life by effectively managing the on-scene response from initial arrival through patient transport and reunification. Students will apply the tactics and techniques that enable first responding officers to “stop the killing” and “stop the dying.”

Students will learn the principles of integrating medical personnel into the follow-on response. Students will discuss and practice establishing and maintaining leadership and communication, creating and maintaining Warm Zones and Casualty Collection Points (CCPs) and victim exfiltration.

Topics Include

Establishing Incident Command and a Warm Zone; Integrated Law Enforcement and EMS team tactics for responding to an ASE; Operating in an indirect Threat Area; Establishing a CCP; Life-Saving Medical Interventions and triage.

Cost

There is NO FEE for this course. *Lunch will be provided.* Travel and all other meals are the responsibility of the course participant.

Audience

The target audience for this course is Law Enforcement and EMS providers. Law Enforcement students must be certified Police/Peace Officers who are authorized to carry a firearm in the course of his/her duties to attend this course, have successfully completed either LASER, IRAS or ALERRT and provide a certificate of completion. You must also be a U.S. citizen or have prior approval. The New York State Division of Homeland Security and Emergency Services (DHSES) reserves the right to determine eligibility for this course.

NOTE This course is comprised of several activities requiring physical exertion. This includes a great deal of time walking, jogging and standing, as well as the negotiation of stairwells between multiple floor levels. Some of this activity may be conducted in low-light conditions. Accordingly every student should be aware of this and consider self-exclusion if s/he has concerns about their physical condition or suffers from any health or other physical abnormality that may place them at risk during periods of significant physical exertion.

Student Equipment Requirements

Law Enforcement students should bring their duty belt. You may bring a ballistic vest if you wish, but it is not mandatory. Both LE and EMS students should wear comfortable clothes conducive of scenario –based training. Each officer is responsible for properly securing his or her weapon(s) during the training course. No personal or agency weapon (including impact and less-than-lethal weapons), live ammunition, weapon magazines, or flash bangs are to be on the officer or in the training area (including classroom) at any time during this course. Note: The SPTC has gun lockers for the storage of weapons during class.

Registration Process

All student registrations will be reviewed by the SPTC with approvals sent to students **NO LATER THAN 2 weeks** prior to the start of the class. Registration does not guarantee a seat in the class. If you are accepted into this course, you will receive a confirmation email from the Center.
