### **Description:**

This course provides participants with a forum to address emergency preparedness, prevention, protection, mitigation, response, and recovery related to critical incidents affecting your institution. You will learn to manage a critical incident by applying an all-hazards, multi-disciplinary, community approach based on the National Incident Management System's (NIMS) Incident Command System (ICS) and Multi Agency Coordination Systems. The course combines lecture and team activities and culminates with an instructor-led, role play exercise customized to your community. This course is taught in partnership with The International Association of Campus Law Enforcement Administrators (IACLEA).
